- Student representatives.


Waste Management Methods:

Solid Waste Management:

- ➤ Every day all the academic buildings and other surrounding area in the campus are cleaned by Maintenance department.
- > Two bins system is followed for waste collection one for biodegradable and one for non-biodegradable.
- Non-biodegradable waste is further segregated and disposed through municipality's garbage collection on a routine basis. Liquid Waste Management
 - ➤ Liquid waste from the points of generation like to the hostel, canteen and toilet etc, is let out as effluent into sewage treatment plant.

E-Waste Management

- > Optimum use of all electronic equipment's through repair.
- ➤ Unused and non-repairable waste is disposed by auction method by our management by inviting tenders from eligible vendors from time to time
